Each day will be 18 holes of stroke play competition for a total of 36 holes of stroke play for the championship.

In consideration of the acceptance of this application, and as further condition to my participation in this championship, I further agree to abide by the tournament rules, conditions of competition, local rules, and tournament regulations and requirements pertaining to the championship. These all can be found on the tournament website at www.ohiowomensopen.com. It is my further understanding that my entry fee shall be refunded in the event that this application is not accepted. I further understand my entry fee shall not be refunded after the entry deadline.

Professional fee of \$200 and amateur fee of \$150 includes both tournament rounds as well as a practice round, which can be played August 9 after 1 p.m. and August 10 after 3:30 p.m. The entry fees do not include cart fees. Contestants may take caddies or carry their own clubs as well as renting a motorized cart from the pro shop.

Those playing in the tournament and living within 60 miles of Defiance are encouraged to play their practice round at an earlier date. Tee times may be made by calling 419.784.5571.

The registration deadline is August 8 either online or through the mail at 5 p.m. There will be no exceptions to this. Tee times will be posted online at the tournament website August 9.
